## Pool Party Policy & Contract Agreement

To book a party, please contact Head Lifeguard, Lily Lewis at (731) 616-4142 or Lifeguard Manager, Emily Fortner at (731) 217-3604.

**Please book ALL parties at least one week in advance.**

In planning your party, we ask that you please remember that Ramblewood Pool is a member-owned facility. We cannot close the pool for parties. Parties are not to exceed 2.5 hours. This allows 2 hours of swimming/food/gifts and an additional 15 minutes to set up before the party start time and 15 minutes to clean up. We must limit the size of the parties for other families to enjoy their time at the pool.

1. Ramblewood Pool Members must pay a **\$50 facility fee** for all parties.
2. No party is booked until the \$50 fee has been paid.
3. All non-member swimming party guests are charged \$5 per person.
4. The **maximum number of guests (swimming and non-swimming)** is **30 people**. This includes parents or guardians of swimmers.
5. Due to TN State law, we require an additional lifeguard for all parties. **The host is responsible for paying the additional lifeguard at a rate of \$50 per party.** Party host(s) must pay cash (or digital payment if lifeguard agrees) directly to the lifeguard at the end of the party.
6. Party host(s) may decorate the pavilion area only and are responsible for cleaning up all decorations when the party has ended. Party hosts must clean up all messes left by party guests. Each party is allowed up to 3 picnic tables in the pavilion area.
7. **Damage to Pool and/or Pavilion area:** The host member(s) are responsible for replacement cost of any damage to pool or pavilion areas or equipment.
8. Please remember that our lifeguards are there to work and have safety regulations they must follow. Please do not distract the lifeguard while he/she is on duty.
9. Before being allowed into the pool, party guests will be informed by the lifeguard of the pool rules and will conduct a swim test before allowing guests to swim in the deep end. YOU are responsible for your guests. **Any guest that is unable to swim MUST wear an appropriate life jacket (not provided by pool).**
